

Supported and Older people's Housing - Development Survey 2025 questions

Page 1: Welcome

The NHF is repeating its survey of members on plans and appetite for the development and regeneration of supported and older people's housing. We also want to understand the barriers and opportunities to developing specialist housing, and what your plans would be with the right funding and operational landscape.

We are aware that the sector has faced significant financial challenges in recent years, alongside an environment of continued uncertainty around further regulation and financial measures affecting the development or sustainment of supported housing. With this context in mind, we also want to understand the extent to which the closure of schemes is a risk for our members, and whether this affects certain client groups more than others.

The findings of this survey will provide vital data on how a stable and sustainable funding and regulatory environment can support the delivery of much needed new supported and older people's housing. By demonstrating the real risk of supported housing schemes closing, we will strengthen our asks to government and [campaigning activity](#) to save our supported housing.

We will ask you questions about your current supported or older people's homes and on your plans for future development and regeneration. There will also be questions on barriers to development and regeneration, and on funding streams.
